Minutes of the Regular Board of Trustees

February 2, 2015

Meeting was called to order by President Frome at 6:30 pm

Roll Call:

Trustees Pokallus, Schafer, Day, Maurer, Toufar and Hagen were present

Minutes:

(Hagen)(Toufar) was carried to approve the minutes as read

<u>Citizen Comments</u>: There were no comments from citizens

Public Works Report:

Joe Scidmore reported that the Christmas decorations removal went off without a hitch. Joe added that he has finished the draft copy of the Emerald Ash Borer evaluation, which he is conducting for the village

Dean Smith reported that the transducer probe has failed at Well #5. Dean has already received the replacement probe and is currently installing it

Chris Helgestad highlighted a sewer backup that occurred last Saturday. Chris reported that the blockage was removed from the sewer main

It was also added that We Energies will be trimming trees around power lines in the area

Police Chief's Report:
