# Village of Spencer Minutes of Regular Board of Trustees Meeting Monday, March 11, 2024, 6:30 P.M. Spencer Municipal Complex

President Toufar called the meeting to order at 6:30 pm.

The Pledge of Allegiance was recited.

#### **Roll Call**

Trustees Carolfi, Jicinsky, Hoes, Schafer, Krause, White, and Toufar were present.

#### **Approval of Minutes**

(Jicinsky)(Carolfi) was carried to dispense with the reading of the previous Regular Board of Trustees meeting minutes and approve them as printed.

# **Announcements**

Annual Chamber Banquet March 21<sup>st</sup>, 6:00 PM at Spencer Kids Group, RSVP. Spring Election is April 2<sup>nd</sup>. Voting by Absentee ballot runs from March 19<sup>th</sup> through March 29<sup>th</sup>. The public test of Village voting equipment will be on March 26<sup>th</sup> at 10:00.

#### **Public Works' Report**

Assistant Wastewater Operator Trevor Ackman reported that in February the WWTP treated 7.4 million gallons of wastewater. Hemlock and Pine Street lift station plans were finalized and are out for bid. Dissolved oxygen and oxygen reduction potential probes failed on the oxidation ditch; new probes are on order through Crane Engineering. The Pista startup is scheduled for April 3<sup>rd</sup>. We plan to begin install next week as an effort to reduce the amount of downtime, but also ensure that we have the install complete before the startup. Both mixing pumps are back online with the help of Crane Engineering. Trevor has been studying for the DNR Wastewater exams and plans to take his first test in April. Water Department treated 3.4 million gallons of water. Details and specifications were finalized with Town & Country for the water plant and Park Street projects prior to sending out for bids. Water main break was repaired in the 300 block of E Clark Street. Walking path bridge was constructed. Mike has begun street sweeping activities. New ADA compliant swing was installed at Madison Street Park. Ash and debris from brush burning is being hauled out to Casey Krause's abandoned pit for disposal.

# **Police Chief's Report**

Chief Bauer reported, that during the month of January, officers handled 174 calls for service, issued 30 citations and 8 written warnings. Chief Bauer attended a meeting at Spencer Kids Group and met with Marathon County Information Technology. Officers completed training pertaining to officer wellness. The police department would like to remind residents of the nuisance property ordinance. The police department will be contacting property owners who are in violation of nuisance property. With the warmer weather, we are encouraging property owners to clean up junk from their property. Routine maintenance was performed on all the department vehicles.
