(Schafer)(White) was carried to approve a camera system for the Complex Building from Priority Business Solutions.

(Carolfi)(Schafer) was carried to approve a Temporary Class "B" Retailer's License for the Spencer Area Fire Department located at 206 E Willow Dr for their Fall event on October 26, 2024.

(Carolfi)(Schafer) was carried to approve S.D. Ellenbecker's Change Order #1 for the Band Shelter project for a savings of \$2000.

(Jicinsky)(Carolfi) was carried by unanimous roll call vote to approve Switlick & Son's Change Order #1 for the Park Street project for a cost of \$73,971.50.
